Important considerations for gifts of mutual funds or securities

If the securities you intend to give are worth less than you paid, you may want to consider selling the securities yourself and gifting the cash proceeds to Thrivent Charitable Impact & Investing. You may be entitled to take a loss on your tax return. In addition, a donor who gives cash can deduct up to 50% of their adjusted gross income in the year of the gift (with a five-year carry-over). (Donors giving long- term securities can deduct up to 30% of their adjusted gross income.)
